LEADERSHIP LICENSURE PROGRAM (LLP)

The MSAA Leadership Licensure Program (LLP) offers robust instruction and curriculum development, preparing aspiring administrators for Massachusetts provisional or initial licensure as Principals/Assistant Principals (PreK-8; 5-12) or Special Education Administrators, and Supervisors/Directors.

This comprehensive program is grounded in effective teaching, learning, and best practices in instructional and organizational leadership. It focuses on the Administrative Leader Guidelines, Massachusetts Curriculum Frameworks, and Culturally and Linguistically Sustaining Practices, ensuring candidates are ready to lead in public schools.

Candidates achieve initial licensure by successfully completing the Performance Assessment for Leaders (PAL) Tasks, which are woven into a practical performance assessment within each module. The LLP's unique integrated and collaborative approach helps candidates develop the essential knowledge and skills to meet the Massachusetts Department of Elementary and Secondary Education's Professional Standards and Indicators for Administrators.



LEARNING FROM THE BEST: YOUR PRACTICUM EXPERIENCE

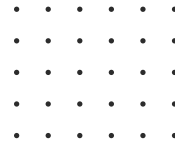

We uniquely embed coursework expectations into a 25-hour Pre-Practicum and a comprehensive 500-hour Practicum, ensuring you can immediately apply classroom learning to real-world school settings. This hands-on approach provides an invaluable, authentic learning experience, connecting theory with practice from day one.

Expert Guidance and Tailored Support

Throughout your practicum, you'll work under the close supervision of a school site supervisor (Supervising Practitioner [SP]) and a Program Supervisor. These seasoned leaders will guide you, customizing your practicum to align with your specific background and career aspirations. Your Supervising Practitioner will actively facilitate practical administrative opportunities and offer ongoing guidance, helping you build essential leadership skills. The LLP Coordinator plays a crucial role in your journey, helping you find the right placement and providing a thorough orientation for all participants.

A Collaborative Path to Licensure

This program is built on a strong collaborative partnership involving the LLP Coordinator, you as the candidate, your Supervising Practitioner, and your Program Supervisor. This dedicated team works together to help you meet the rigorous Massachusetts Department of Elementary and Secondary Education's Professional Standards for Administrators and successfully fulfill the requirements of the Massachusetts Performance Assessment for Leaders (PAL) Tasks. The LLP Coordinator maintains consistent engagement through regular contact, meetings, and observations during both your coursework and practicum. Furthermore, to broaden your perspective and ensure diverse exposure, you'll complete "school diversity visits" in two or more different school environments.

Specific topics covered include equity awareness, advocacy, identifying and closing gaps, social-emotional programming, and the crucial role school counselors play in ensuring all K-12 students graduate career and college ready.
